WHEREAS:

By a RestatedShareholder Agreement dated 12.12.2022 ("Agreement") amongstAwfis Space Solutions Private Limited(Company), Mr. Amit Ramani (Promoter), SCI Investments V(SCI/Existing Investor), Bisque Limited(Bisque), Link Investment Trust(Link), Ashish Kacholia (Transferor), The Persons Listed in Part A of Schedule VII annexed with the Agreement (Series F CCCPS Investors) and The Persons Listed in Part C of Schedule VII annexed with the Agreement (Series F OCRPS Investors), recorded the rights and obligations agreed to amongst them in respect of the management and control of the affairs of the Company and certain rights and obligations, inter se in accordance with the terms and conditions set out in the said Agreement.

This Deed shall be governed by and construed in accordance with the laws of India. The terms and conditions of the Agreement in relation to the provisions regarding arbitration and other terms and conditions shall be deemed to have been incorporated in this Deed.
