DEED OF ADHERENCE

This **DEED OF ADHERENCE** ("**Deed**") is executed on this 15th day of January 2024 by Mr Tarun Khanna S/o Satbir Singh Khanna R/o B-9/21 Second Floor, Vasant Vihar, New Delhi -110057 (the "**Transferee**") effective from 08th day of January, 2024.

WHEREAS:

By a Restated Shareholder Agreement dated 12.12.2022 ("Agreement") amongst Awfis Space Solutions Private Limited (Company), Mr. Amit Ramani (Promoter), SCI Investments V (SCI/Existing Investor), Bisque Limited (Bisque), Link Investment Trust (Link), Ashish Kacholia (Transferor), The Persons Listed in Part A of Schedule VII annexed with the Agreement (Series F CCCPS Investors) and The Persons Listed in Part C of Schedule VII annexed with the Agreement (Series F OCRPS Investors), and between, inter alios, Peak XV, Bisque, Link, New Shareholder, Series F Investors, the Promoter and the Company ("Buy-Back Addendum") and Addendum To The Restated Peak XV, Bisque, Link, New Shareholder, Series F Investors, the Shareholders' Agreement dated 4th December, 2023 executed by and between, inter alios, Peak XV, Bisque, Link, New Shareholder, Series F Investors, the Promoter and the Company of the management and control of the affairs of the Company and certain rights and obligations, inter se in accordance with the terms and conditions set out in the said Agreements.

Definitions and Interpretation.
